ORDINANCE NO 96/2024 OF THE RECTOR OF THE SILESIAN UNIVERSITY OF TECHNOLOGY of 20 June 2024

on the organisation of the academic year 2024/2025 at the Silesian University of Technology

Pursuant to Article 23 section (1) of the Act of 20 July 2018. - Law on higher education and science (consolidated text, Journal of Laws of 2023, item 742, as amended), in accordance with § 25 section (5) of the Study Regulations constituting an attachment to the Resolution no. 6/2024 of the Senate of the Silesian University of Technology dated 25 March 2024 on the Study Regulations (Legal Monitor of the Silesian University of Technology of 2024, item 307), it is ordered as follows:

§ 1

1. The ceremonial inauguration of the academic year 2024/2025 will take place on 2 October 2024 at 11:00 am.
2. The academic year 2024/2025 comprises:
 - 1) the winter semester, including:
 - a) classes 01.10.2024 (even-numbered week) - 03.02.2025,
 - b) winter holidays 23.12.2024. - 07.01.2025,
 - c) an additional day for the completion of uncompleted curricular activities or the organisation of zero examination dates 04.02.2025,
 - d) winter examination session 05.02.2025. - 11.02.2025,
 - e) resit winter examination session 12.02.2025. - 25.02.2025,
 - f) inter-semester break 26.02.2025 - 28.02.2025,
 - g) semester settlement date 28.02.2025,subject to section (3);
 - 2) the summer semester, including:
 - a) classes 01.03.2025 (odd week) - 29.06.2025,
 - b) spring holidays 17.04.2025. - 22.04.2025,
 - c) additional days for the completion of unfinished curriculum classes or the organisation of zero examination dates 30.06.2025. - 02.07.2025,
 - d) summer examination session 03.07.2025. - 09.07.2025,
 - e) resit summer examination session and 10.07.2025. - 16.07.2025, and 11.09.2025 - 21.09.2025,
 - f) summer holidays 17.07.2025. - 10.09.2025,
 - g) inter-semester break 22.09.2025. - 30.09.2025,
 - h) semester settlement date 30.09.2025,subject to section (4);

3. The winter semester being the last semester of the first-cycle programme shall include:
 - 1) classes 01.10.2024 (even-numbered week) - 13.01.2025,
 - 2) an additional day for the completion of uncompleted curricular activities or the organisation of zero examination dates 14.01.2025,
 - 3) winter examination session 15.01.2025 – 21.01.2025,
 - 4) resit winter examination session 22.01.2025. - 04.02.2025,
4. The summer semester being the last semester of the first-cycle programme includes:
 - 1) classes 01.03.2025 (odd week) - 07.06.2025;
 - 2) additional days for the completion of uncompleted curricular activities or the organisation of zero examination dates 05.06.2025, 06.06.2025, 09.06.2025;
 - 3) summer examination session 10.06.2025. - 16.06.2025;
 - 4) resit summer examination session 17.06.2025. - 06.07.2025.
5. Public holidays free from classes:
 - 1) in the winter semester - 1 and 11 November 2024;
 - 2) in the summer semester - 1 and 3 May, 8 and 19 June 2025.
6. Additional days free from classes:
 - 1) in the winter semester: 2 October 2024. - ceremonial inauguration of the academic year;
 - 2) in the summer semester:
 - a) 2 May 2025. - Rector's Day,
 - b) 7 May 2025. - Sports Day,
 - c) 30 May 2025. – Igry Juwenalia Gliwickie,
 - d) 20 June 2025. - Rector's Day.

§ 2

1. The course schedules must be settled in such a way that all courses can be completed within the time period specified in §1 section (2) pt. (1a), §1 section (2), pt. (2a), §1, section (3), pt. (1), and §1, section (4), pt. (1), respectively, for courses in a given semester.
2. Uncompleted classes resulting from the curriculum and study plan must be completed before the beginning of the examination session, in particular during the period referred to in § 1, section (2) pt. (1c), § 1, section 2 pt. (2c), § 1, section (3) pt. (2), and § 1, section (4) pt. (2), respectively, for classes in a given semester.

§ 3

1. The course instructor, in consultation with the Year Representative, shall define:
 - 1) deadlines for credit in accordance with the procedure defined in § 41 of the Study Regulations annexed to Resolution No. 6/2024 of the Senate of the Silesian University of Technology dated 25 March 2024;
 - 2) dates for the examination pursuant to the procedure defined in § 42 of the Study Regulations referred to in point (1).
2. It is recommended to conduct the examination on an additional date, the so-called zero date. It is recommended that a zero date be established before the examination session, in particular during the period referred to in §1 section (2) pt. (1c), §1 section (2) pt. (2c), §1 section (3) pt. (2) and §1 section (4) pt. (2) respectively for classes in a given semester. The relevant provisions of the Study Regulations apply to the organisation of zero examination dates.
3. The course instructor or a person authorised by them shall enter the course credit and grade in USOS by the date specified in § 44 section (2) and (3) of the Study Regulations referred to in section (1) pt. (1).
4. In the case of students taking courses in their final semester of study, the course instructor or a person authorised by them should enter the course credit and grade in USOS immediately after the student obtains the credit and grade.

§ 4

1. Diploma examinations shall be conducted on dates specified in § 63 of the Study Regulations referred to in section (1) pt. (1).

2. The Vice Dean for Education/Deputy Director for Education is obliged to ensure that first-cycle students wishing to participate in the recruitment for second-cycle studies are able to take the diploma examination within the dates:

- 1) in the winter semester - by 10 February 2025;
- 2) in the summer semester - by 14 July 2025.

§ 5

The Rector reserves the right to change the organisation of the 2024/2025 academic year, also during the 2024/2025 academic year, in the event of special circumstances justifying such a change.

§ 6

The Ordinance shall enter into force on the date of its signing, with effect from 1 October 2024.
