ORDINANCE NO 160/2024 **OF THE RECTOR OF THE SILESIAN UNIVERSITY OF TECHNOLOGY** of 30 September 2024

on a grant for doctoral students from abroad **under the Excellence Initiative – Research University programme**

Acting pursuant to Article 23 section (1) of the Act of 20 July 2018. - Law on higher education and science (consolidated text, Journal of Laws of 2023, item 742, as amended), in connection with the participation of the Silesian University of Technology in the Excellence Initiative - Research University programme (contract no. 08/IDUB/2019/94 of 16 December 2019), it is ordered as follows:

§ 1

1. The programme covers doctoral students of the Silesian University of Technology from abroad studying at the Joint Doctoral School.
2. The Rector, within the available funds in the Excellence Initiative - Research University programme, upon a request of a doctoral student submitted to the Doctoral School, may grant a subsidy for accommodation costs in the amount of up to:
 - 1) PLN 600 gross per month for a doctoral student studying in the first year and
 - 2) PLN 400 gross per month for a doctoral student studying in years II, III and IV.A template application form constitutes Attachment No. 1 to the present Ordinance.
3. Doctoral students may receive the subsidy after the Doctoral School has confirmed their arrival to the Silesian University of Technology and upon presentation of documented costs incurred in connection with accommodation at the place of study.
4. For doctoral students admitted to the second, third and fourth year of education at the Doctoral School, a positive opinion of the Director of the Doctoral School is the condition for receiving the grant.
5. The formal assessment of the application is conducted by a committee consisting of: Vice Rector for Science and International Cooperation, the Director of the Doctoral School and the Head of the International Relations Office. The committee prepares a report according to the template constituting Attachment No. 2 to the present Ordinance.
6. The Rector shall take a decision on granting the subsidy no later than 30 days from the date of submission of the application, taking into account the opinion of the committee referred to in section 5.
7. In the case of doctoral students who rent a room in a student house or in the Assistants' House belonging to the Silesian University of Technology, the grant awarded is transferred directly to the place of accommodation in the form of covering full or partial costs resulting from the applicable rental rates.
8. The subsidy shall be withheld in the event of discontinuation of education or at the request of the Director of the Doctoral School justified by the failure of the doctoral student to fulfil their obligations.
9. The amount awarded shall be paid on the basis of the documents presented in the application and the report of the Committee.
10. participation in this programme does not limit participation in other pro-quality programmes.

§ 2
