In accordance with Regulation (EU) 2016/679 of the European Parliament and of the EU Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter referred to as "GDPR"):

- I consent / do not consent* to the processing by the Silesian University of Technology of my personal data provided in the Competition registration form or during the Competition in order to register participation in the Competition, communicate with the Participants for organizational purposes, document the course of the event and award prizes.
- I consent / do not consent* to use my name, surname, image, voice and information about the place in which I live, as well as information about the results of the Competition in relation to my Competition work in order to inform (also in the media) about my participation in the Competition.

5. I acknowledge the following information from the Organizer:

- a) The controller of the Participant's personal data is Silesian University of Technology, ul Akademicka 2A, 44-100 Gliwice; BR@polsl.pl; in order to contact the Organizer of the Competition, the Participant may write to the following e-mail address: konkurs3MT@polsl.pl, The Data Protection Officer can be contacted by e-mail at IOD@polsl.pl.
- b) Personal data provided by the Participant in this form or later during the Competition is processed in connection with the participation of the Competition, in order to organize and conduct the Competition, document its course, communicate with the Participants and inform about the results, including publication of information about the Competition winners and their works on the website <https://www.polsl.pl/rjo7-cpn/konkurs-three-minute-thesis/> and in the media, payment of prizes, as well as for archiving and accountability purposes required by regulations. The legal basis for the processing of personal data is Article 6(1)(a) of the GDPR, i.e. your consent, as well as Article 6(1)(e) of the GDPR, i.e. the implementation of public tasks related to the mission of the University and, in the case of receiving an award, also Article 6(1)(c) (tax law). You can withdraw your consent at any time by sending an e-mail to konkurs3MT@polsl.pl – which does not affect the lawfulness of the processing carried out before the withdrawal of consent.



- c) Persons whose personal data is processed by the Organizer have the right to:
- access their personal data;
 - request rectification of data that is incorrect;
 - request the deletion of the data when the data is not necessary for the purposes for which they were collected or after objecting to the processing of the data, the data is processed unlawfully;
 - request the restriction of data processing when these persons dispute the accuracy of the data, the processing is unlawful and these persons object to the deletion of the data, the Organizer no longer needs the personal data for the purposes of processing, but they are needed by the data subjects for the establishment, exercise or defence of claims, or when these persons have lodged an objection to the processing of data – until the overriding interests of the controller over the basis for such objection have been established;
 - object to the processing of data – for reasons related to the special situation of the persons whose data are processed;
 - lodging a complaint to the supervisory body dealing with the protection of personal data, i.e. the President of the Office for Personal Data Protection, ul Stawki 2, 00-193 Warszawa.
- d) Providing personal data is voluntary, but necessary to enable the Organizer to organize the Competition and notify the winners of the awards.
- e) Personal data provided by the Participant processed in connection with participation in the Competition will be processed for the period of storage of financial and accounting documentation or until the consent is withdrawn.
- f) Personal data provided by the Participant will not be disclosed to other entities, except entities authorized by law.
- g) The Organizer does not intend to transfer personal data to third countries and international organizations.
- h) The Organizer does not process the personal data of the contest participants in a manner based solely on automated processing, including profiling.
6. In addition, we would like to inform you that in order to document the competition, photographs and videos may be taken during the competition, which may be published on websites and in publications belonging to the Silesian University of Technology.
